OBSERVING THE CONDUCT OF CHILDREN:

1. All children like to be treated with respect and courtesy.
2. They want adults to recognize their good traits and abilities.
3. Most of them dread to be singled out for disciplining.
4. A few students will make problems of themselves in order to gain attention and recognition.
5. Students who are willing to comply with regulations may become problems if the person in control of the group is too lax and indifferent toward gross violations of a few; or if the person in control appears unreasonable in his or her demands, or if he vacillates from extreme permissiveness one moment to extreme control the next.

Suggestions for monitoring the operation of school buses:

- Review driving record, annually.
- Supervisors should make on-the-road school bus driver observations on a regular basis by supervisors.
- Attend Crash Review Board meetings.
- Require drivers involved in a preventable accident to attend a mandatory Behind-the-Wheel training session.
- Document all telephone calls regarding school bus drivers and the driver's rebuttal and the action taken by the supervisor, if action was necessary.
- Establish a written policy regarding requirements for continued employment for a driver involved in a preventable school bus accident.
 1. First Preventable Crash:
Behind-the Wheel training may be required with pay and disciplinary action may be taken.
 2. Second Preventable Crash within a 10 month period:
Behind-the-Wheel training and classroom training attendance will be required, leave without pay for a given length of time, and possibly other disciplinary action.
 3. Third Preventable Crash within a 20 month period:
Dismissal

NATIONAL SCHOOL BUS SAFETY WEEK

OCTOBER 16 – 22, 2005

What is your office doing to promote school bus safety in your school division? Have you notified all of your schools and school bus drivers? Have you provided them with ideas for recognizing this special week? Do you encourage the school administrators to set aside a day during this week to show their drivers their appreciation for the important role they have in the school?

Suggestions:

- Contact your local news media and radio/television stations to promote the purpose of National School Bus Safety Week. Have diagrams in the newspaper or flyers sent home from schools showing when motorists are required to stop for a school bus; i.e. at intersections, dual lane roadways with or without a median..... and the penalty for failure to stop as required.
- Contact all schools and suggest a daily reminder in their morning/afternoon announcements to cover various safety issue regarding riding a school bus, i.e. cross the roadway in front of the bus after the driver signals them to cross and they have looked for approaching traffic too. Stay seated while the bus is in motion. No eating or drinking on the school bus. There are other rules they should be reminded of that are listed at the front of the school bus.
- Does your department provide all schools with films related to school bus safety?
- Do your schools schedule a student assembly to review school bus safety topics? You may want to invite an officer from the Sheriff Department, State Police or city police to talk to the group. This would be a good time to show movies on school bus safety. Maybe you would like to invite parents to your high school assemblies since there should be an emphasis on the law regarding stopping for a school bus at the high school level.
- Schools may want to schedule school bus emergency evacuation drills during National School Bus Safety Week. Are the instructions that you provide the schools for conducting such a drill up-to-date?

Let's do all we can in Virginia to get everyone's attention to their responsibility for school bus safety each day.
